






SYSTEM LANDSCAPE OVERVIEW








Lemur Map Integration with Work Manager

 Local view displays the location and details of each work order or notification to start/pause/complete their work.




Asset Data Governance



- Process driven supported by integrating GIS and Work Manager with Master Data Governance MDG
- Enforcement of quality data standards across the systems
- Enhanced sync framework supports data transfer between GIS and SAP through a custom derivation framework
- Functionality exists to create change requests in MDG as Work Manager syncs with SAP.


Settlement Rule
