








### SAP AFS Recent Improvements

- GDPR requirements expect any personal sensitive data to be deleted/blocked after the purpose for which it is created is over
- Additionally when personal sensitive information is available in the system there has to be a possibility to report what information about a data subject is saved in the system
- DPP enhancements for AFS are available in AFS 608 only
- The enhancements are related to:
  - Simplified deletion and blocking of Personal data
  - Framework for Retrieval of Personal data







#### SAP FMS Recent Improvements

#### **Enhancement in functionality**

Immediate delivery without immediate allocation for STO

During bulk order processing, where Stock Transport Order(STO) is being created, immediate delivery might not happen for ARUN relevant articles if immediate allocation does not happen due to material locking issues. This happens if immediate allocation is enabled for order type based on sales area and immediate delivery is maintained for order type in customizing. With this development, outbound delivery should get created directly without going through immediate allocation inside the STO, thus avoiding locking issues.

#### **Performance improvements:**

- In FSH\_PCW for confirmation operations by introducing parallelization
- In MASS ATP by HANA query optimization
- SDRQ report optimization for memory consumption(from 5+GB to 150-200MB) & execution time (from 17000+ sec to 1500-2000 secs)
