

Design

- Detailed Change Impact analysis

Validation – Testing Evidence gathering

- Testing should not only be done but also gather testing evidence
- Peer review the testing evidence and make sure nothing is left for a chance
- Run a parallel environment when testing which will help testing a Go-Live day environment test
- Prepare the scripts if any to automate regression testing.



Typical Go-Live day Activities


- Have some cushion time for downtime
- Make sure you do a pre-run especially with your networking team involved for any Netscalar/Load Balancing/Firewall ports etc
- Documentation is the key to make sure you follow the sequence of steps to get there.
- Would recommend to use incremental migration on Go-Live date, keep minimal objects to migrate
