Business Payment Coalition ("BPC"): Overview


In August 2021 the Business Payment Coalition along with the Federal Reserve Bank of Minneapolis/St. Paul launched an **e-Invoice Exchange Market Pilot Program** with voluntary participants to create a B2B electronic E-Invoicing Platform for the United States.

<u>Participating companies</u> in the program include national and international e-Invoicing service providers, private companies and subject matter individuals on a voluntary basis as well as SAP. This is an endeavor NOT tied to governmental mandatory requirements today, but rather a process automation, cost efficiency and interoperability driven private initiative.



Goals and Value Proposition:

- Addressing barriers that make difficult the digital adoption in B2B transactions
- Developing and promoting the adoption of electronic standards for invoices, remittances and payments
- Make a straight-through automation process of invoices and payments




