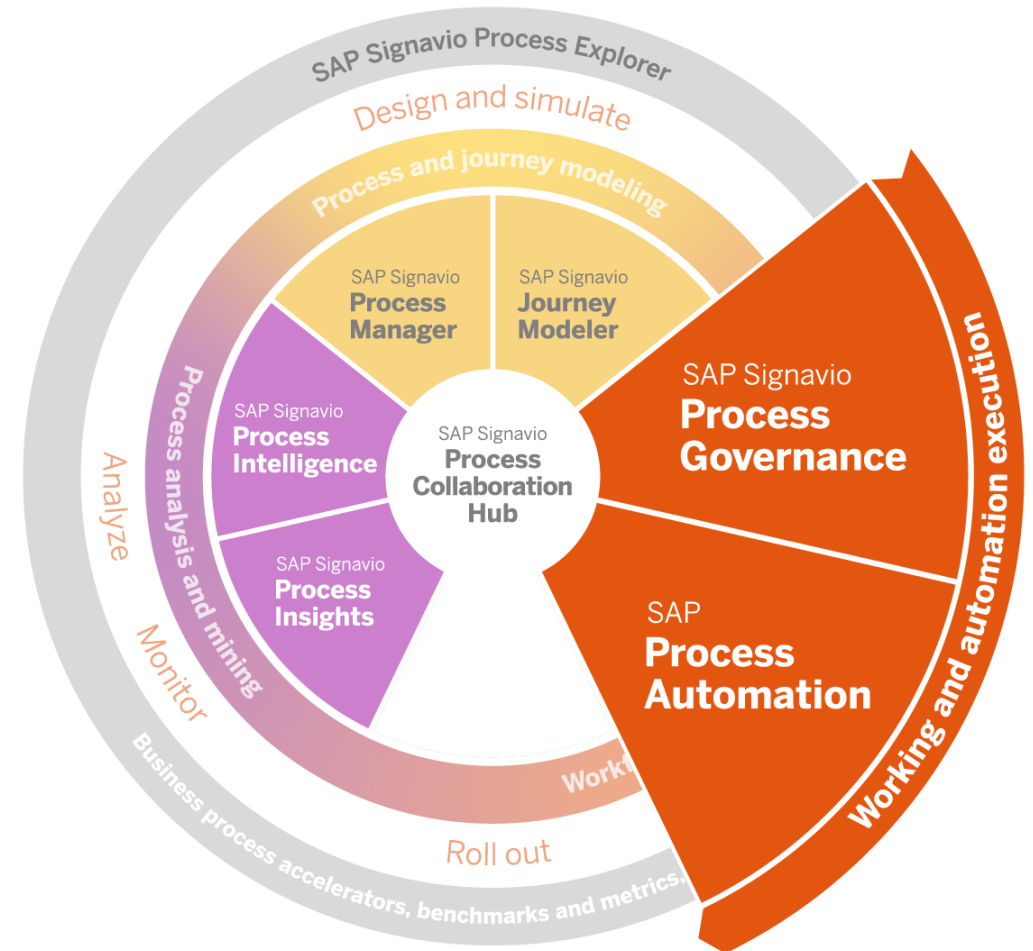
Process governance and automated execution

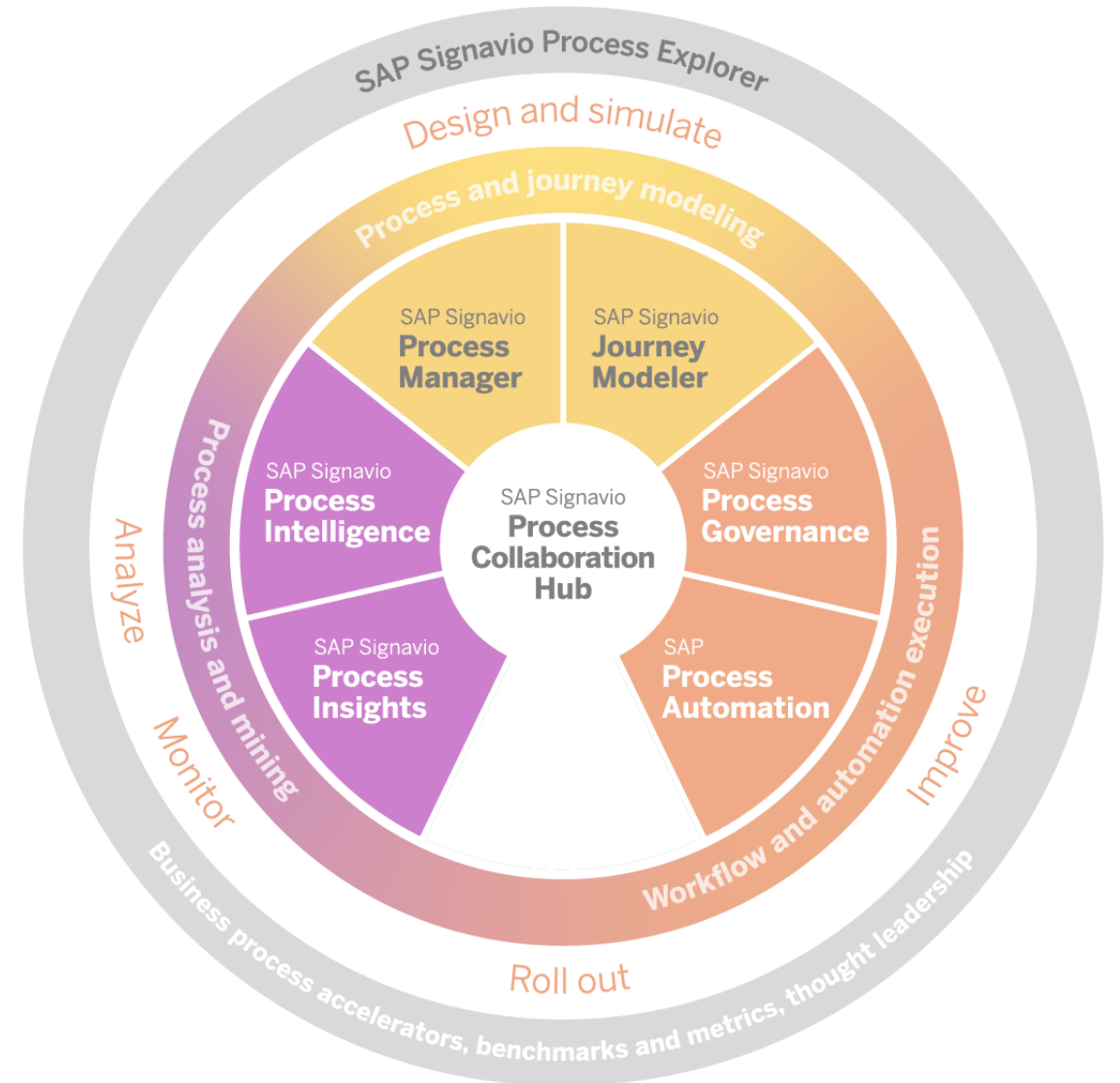
Process collaboration

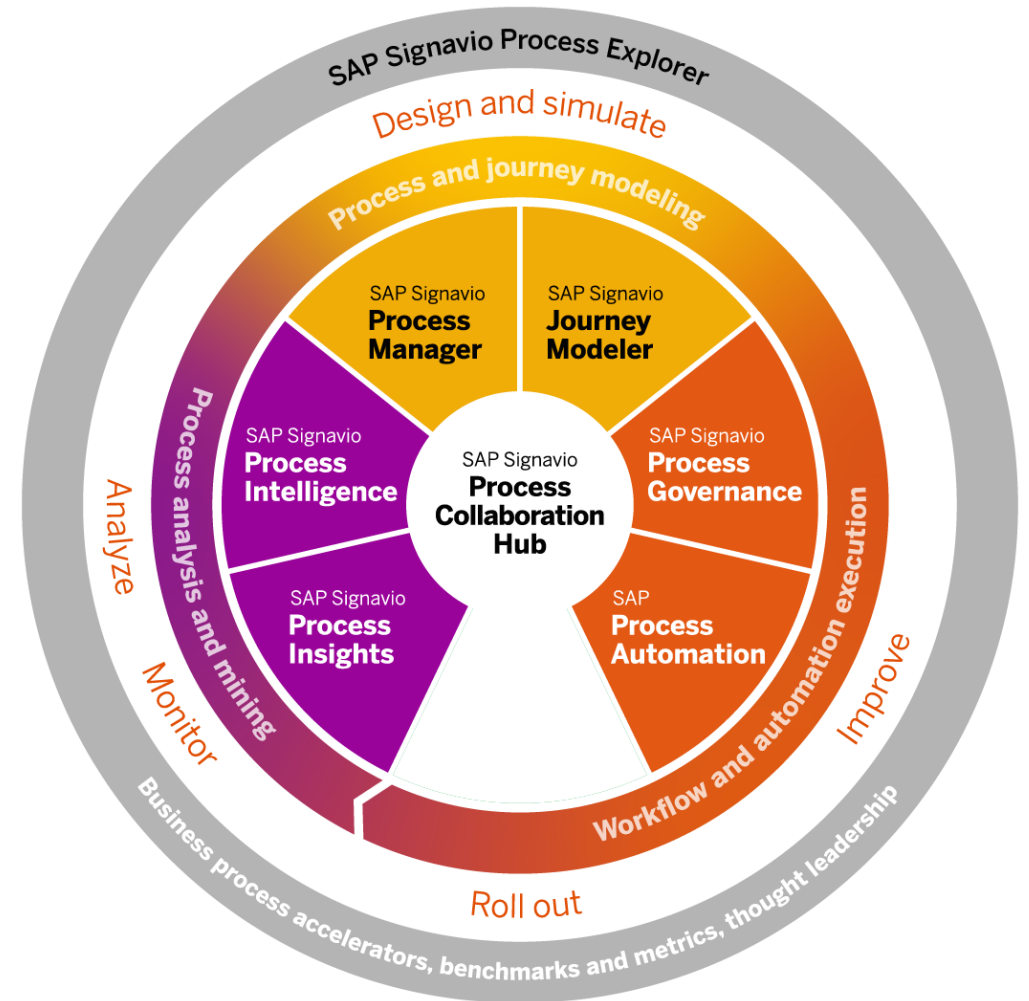

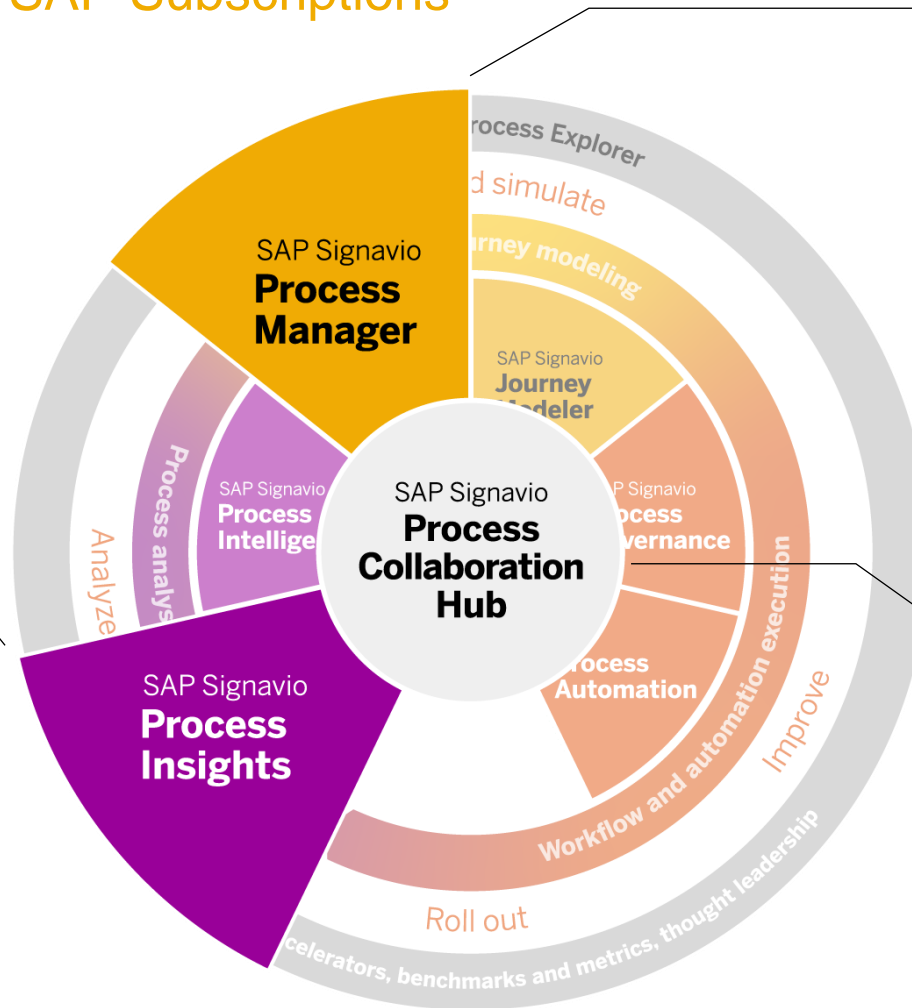
